


## **London Iron Ore Market Report**



A tame afternoon on iron ore with a modest tick down from 113 to 112. Size spread trading was seen at the start and end of the afternoon as AUG/SEP traded 1.85 in 200KT pre open, and AUG/OCT got paid at 3.40 in 100KT on the close.
