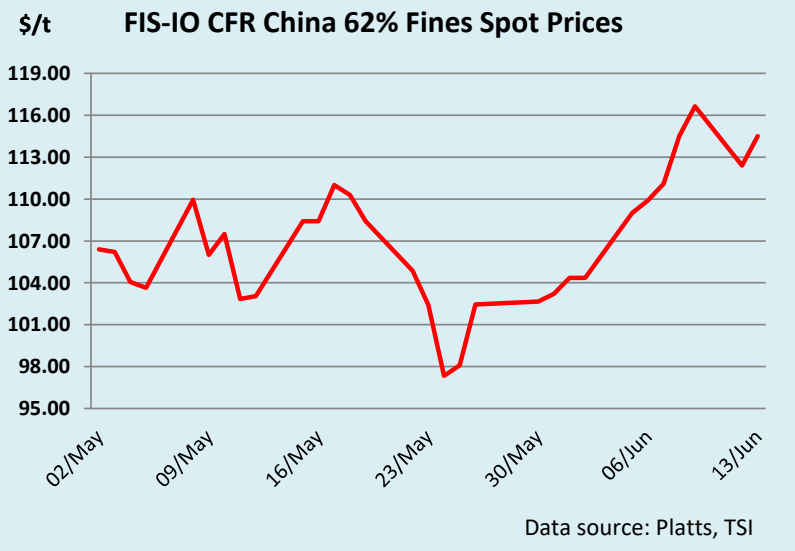

Market Commentary / Recent Trades

Iron ore futures recouped yesterday's losses and moved back to \$113 on Tuesday as market sentiment was boosted by Beijing's stimulus proposals. In an effort to boost short-term liquidity, the People's Bank of China cut its seven-day reverse repurchase rate by 10 basis points today. Investors expect the central bank will cut its one-year loan rate later this week due to Beijing's worries over economic growth. In the futures market, July contract pushed through the \$110 mark to \$111.70 at the time of writing. An uptick in liquidity was seen at the back with decent size on the Cal's trading both as outright and as spreads.

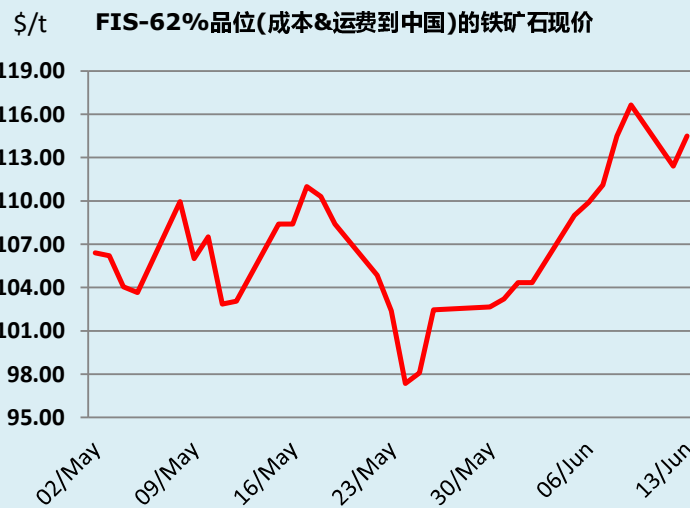

市场评论 / 近期交易

由于中国政府的刺激方案提振了市场情绪，周二铁矿石期货恢复了昨日的损失，并回升至113美元。为了提振短期流动性，央行今日将7天期逆回购利率下调10个基点。投资者预计，由于政府对经济增长的担忧，央行将在本周早些时候下调一年期贷款利率。

期货市场上，铁矿石早盘表现出人意料。在撰写本文时，7月合约价格突破110美元大关，至111.70美元。远期合约流动性也有所上升，Cal交无论是在直接合约还是价差交易规模相当可观。
