


Oil and Energy Market News

Sep23 Brent crude futures settled last night at \$84.24/bbl – however this report is showing the Oct23 Brent prices as this is the more actively traded contract, as we approach the end of the month.

A turbulent morning in the fuel markets has led to me being later on the morning report, apologies for that.

The HSFO EW has continued to chop around this morning amid brash moves in the high sulphur time spreads. The EW has traded a two dollar range around a previous settlement of \$4.25/mt and the Aug23/Sep23 Sing 380cst spread has rallied over a dollar. The equivalent time spread for the Rotterdam 3.5% barges is up 75 cents on the day.

Rotterdam 3.5% barges crack is 40 cents stronger than yesterday, trading last at -\$6.20/bbl in the front month.


