


## 26 July 2023

Limited movement on flat price over the T+1 as iron ore retreated from Sing morning highs of \$116.50 over the course of the day. The main focus of the afternoon was squarely on AUG/SEP which traded consistently at \$1.70 in clips of 5-20KT and \$1.75 earlier on in the afternoon in 100KT. Down the curve activity was limited with the exception of Q4/Q1 which traded \$4.00 in 20KT/m.
