Market Commentary / Recent Trades

Iron ore futures slumped below \$106 Monday as market confidence turned weaker following the ongoing production curbs in Tangshan, meanwhile no updates regarding a new round of stimulus plans from the Chinese government. The main action was on the outrights today with sellers appearing from the opening, Aug sold down from a high \$107 to \$105 where most volumes changed hands, losses were extended in the rest of the session until some support was found at \$103.5. Sept as the active contract, was hit most and lost over \$5 during the Asian day session, opening at around \$106 before falling straight to below \$102 at the close. While Jul eased from sub \$109 to \$107.5 then \$106.5. In the spread, Jul/Aug saw small sizes traded 101.00 at \$3, while Aug/Q4 traded at \$4.55 in the clips of 15kt-30kt in the early London morning.

,直到在103.5美元处找到了一些支撑。9月作为活跃合约,在 亚洲交易时间跌幅最大,跌逾5美元,开盘报106美元左右,收 盘时直接跌至102美元以下。7月从低于109美元跌至107.5美 元,然后又跌至106.5美元。价差方面,7月/8月在3美元有一 些交易,8月/Q4在伦敦早间交易于4.55美元,交易 1.5万至3万吨。
