

Market Commentary / Recent Trades

Iron ore rallied back into \$114 to reverse losses seen on Monday off the back of disappointing GDP data. Inventories have contracted and steel production does appear to be resilient, both of which lend a degree of price support to iron ore. Spreads were seen trading in considerable size primarily at the front of the curve, with most of the quarterly interest focused on Q1 and Q4 outrights. Spreads continued to go further bid across the curve as Cal25/26 was aggressively paid at \$6.55.
