


London Iron Ore Market Report



A slow afternoon on iron ore as SEP hovered around \$100 throughout the session. CAL24/25 was seen trading \$6.70 prior to open with back interest limited from there on. Spread interest was front focused with SEP/NOV trading \$3.35 and SEP/OCT trading \$1.85 both in 100KT clips. Quarterly interest was again focused on Q4, though Q2 was also seen trading at \$91 just in smalls.
