

Iron ore gained modestly on the day, closing \$101.30,. Whilst negative fundamental news out of China persisted, flat price was largely unaffected. SEP/OCT proved the dominant spread tenor, gaining slightly to \$2.05, trading consistently and in size at \$2.00 for the majority of the trading day. The Q4/Q1 spread also widened, finding liquidity in reasonable clips at \$3.35, over the T+1.
