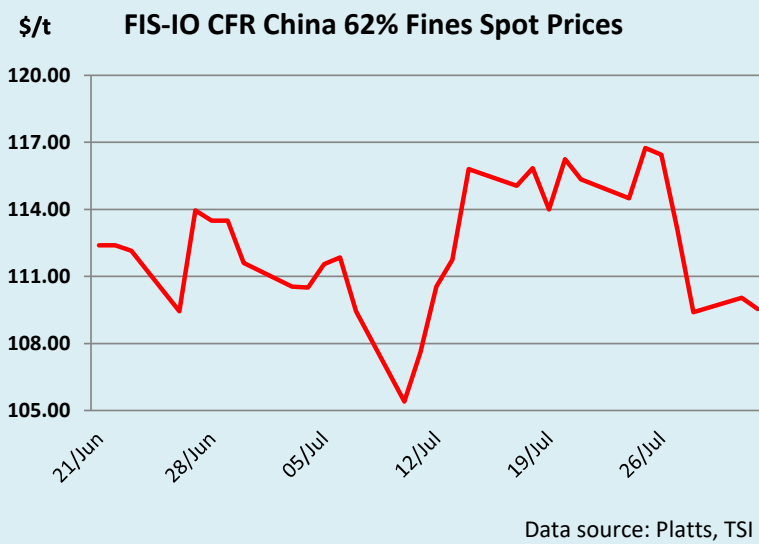

Market Commentary / Recent Trades

Iron ore flat price was reasonably steady over the morning with much of the attention going to front spreads as AUG/SEP traded \$1.70 in over half a million tonnes over the Singapore trading day. Towards the back Q4'23/Q4'24 was seen trading in size at \$12.20 as well as some muted Q4 outright interest going through.

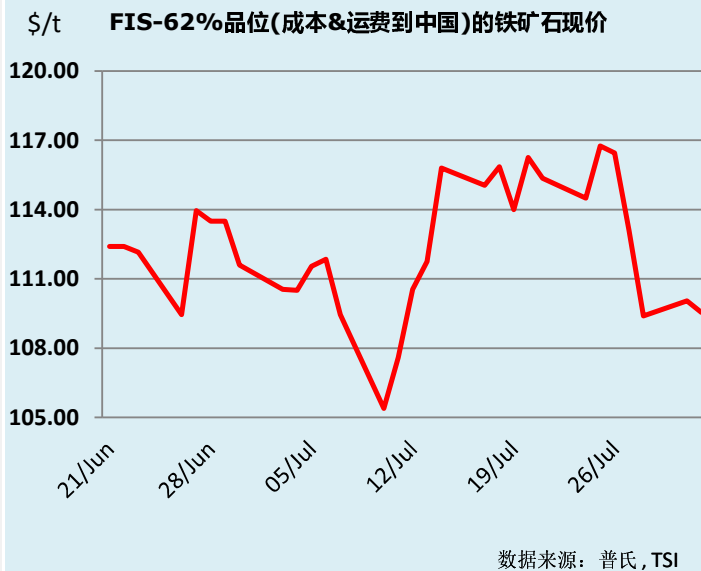
