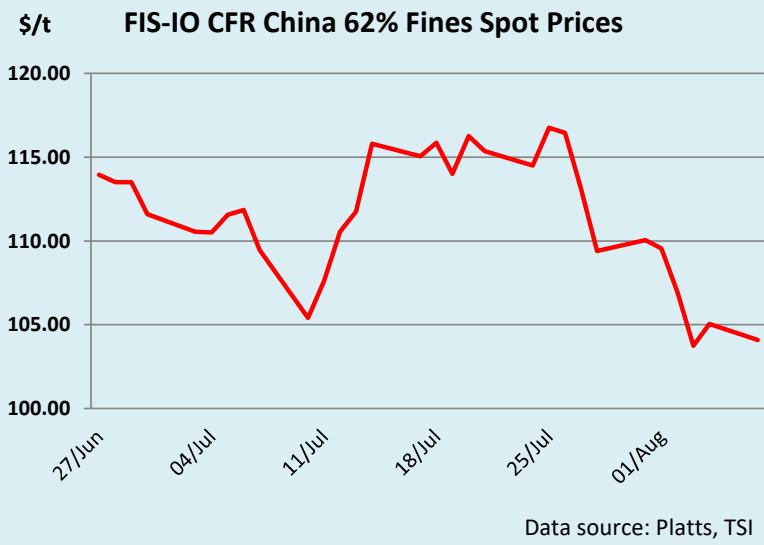

Market Commentary / Recent Trades

A slow start to the week with iron ore futures prices steadying at last Friday's level. Sept contract was stuck at a narrow range of \$100.10-\$100.50 for most of the session, until more volumes later saw trading at \$100.8 and closed slightly above \$101. Both Aug and Oct edged up to \$103.5 and \$99.15 respectively, but all in thin volumes. Spreads wise, main action was taken on Aug/Oct at \$4.40, along with some interest on Dec/Apr at \$4.70.

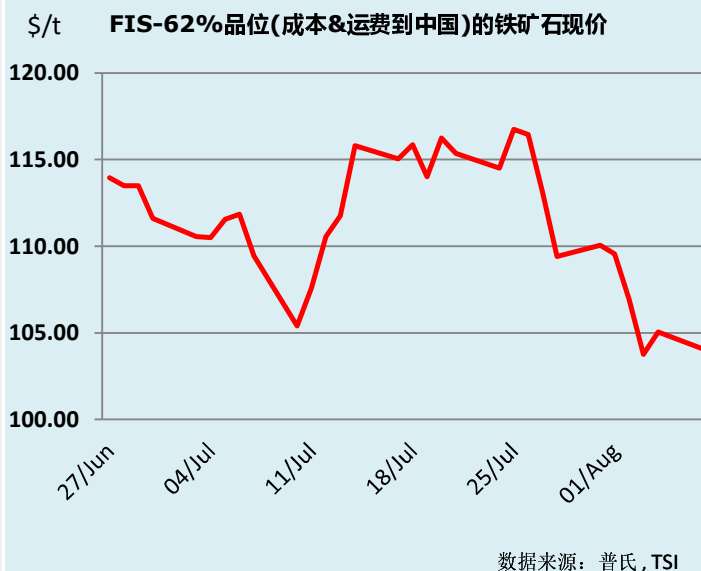

本周开局缓慢，铁矿石期货价格稳定在上周五的水平。9月合约盘中多数时间停留在100.10至100.50美元的窄幅区间，随后成交量增加，交易至100.8美元，收盘略高于101美元。8月和10月分别小幅上涨至103.5美元和99.15美元，但交易量均较少。价差方面，8月/10月交易于4.40美元，12月/4月于4.70美元。
