Market Commentary / Recent Trades

Iron ore picked up on Friday as there was a market rumour about new measures to boost home sales and resolve debt risks, along with increased steel production figures shown in early Aug. Since more steel mills resumed production after completing their maintenance, the daily crude steel output improved by 1.2% or 33,000 tonnes over the first ten days of Aug. As Mysteel industrial survey showed, blast furnace capacity utilisation rate among 247 Chinese steel mills edged up for another week to 91.03% during 28 July-3 Aug, up 0.98% w-o-w; and its average blast furnace operation rate was up 0.44% w-o-w to 83.8%. Meanwhile, according to Mysteel, iron ore inventories at 45 main Chinese ports on 10 Aug dropped to a 34-month low of 119.5 million tonnes, down 2.8% or 3.4 million tonnes from last week due to recovering discharge rates at ports. In the futures market, Sept gradually moved up to the weekly high of \$103 and closed a tick lower. Decent spreads interest was seen on the further back contract with Q4/Q1 traded at \$3.4 throughout the session in the clips of 15-42kt, some sizable trades were also taken on Q3/Q4'25 at \$1.50.

市场评论 / 近期交易

由于市场传闻有关提振房屋销售和解决债务风险的新措施但尚未得到官方确认,同时8月初数据显示钢铁产量有所增加,铁矿石价格周五上涨。我的钢铁网工业调查显示,7月28日至8月3日期间,247家中国钢厂的高炉产能利用率再次小幅上升,达到91.03%,同比上升0.98%;高炉平均开工率周上升0.44%,达到83.8%。与此同时,根据其数据,因港口卸货率回升,8月10日中国45个主要港口的铁矿石库存降至34个月低点1.195亿吨,较上周下降2.8%或340万吨。期货市场方面,9月价格逐渐升至本周最高点103美元,收盘时略微下跌。远期价差合约有不错的市场兴趣,Q4/Q1在3.4美元,每手交易量1.5至4.2吨,Q325/Q425也有良好交易量于1.50美元。
