


## **Oil and Energy Market News**

Brent crude has continued yesterday's climb this morning, trading up from previous settlement of \$93.70/bbl in the front month contract. At this rate, oil is on track to be +4.35% firmer for the week, which would be the third straight week of gains. WTI is above \$91/bbl, also tracking +4% higher for the week.

Amid the backdrop of supply tightness issues, oil prices have been supported by modest upside surprises to China IP and retail sales activity prints today.


