


Oil and Energy Market News

Oil continues its bullish rally this week, with the front month Brent crude futures trading almost a dollar higher than Friday's settlement of \$93.93/bbl. Prices remain supported by tight supply and falling inventories amid OPEC+ cuts until the end of the year.

A slight uptick in demand outlook has also bolstered prices as the market assesses some recovery in China amid stimulus measures such as the reserve ratio cut last week.


