Oil and Energy Market News


Oil prices slipped in the APAC session, with the front month Brent crude future down from last night's settlement of \$93.29/bbl as concerns turn from tight Q4 supply to faltering fuel demand amid central banks holding high interest rates for longer.


Also helping ease the market was Russia partially lifting the ban it had put on diesel and gasoline exports.


