


London Iron Ore Market Report



Iron ore had a volatile day in both the afternoon and evening sessions in the front month contract. The October contract in the morning dropped from a high of \$116.60 to \$115. The spreads widened from the offset with the Sep/Oct widening to \$2.65. This trend continued in the afternoon with the spread reaching \$2.75. We saw a lot of interest in Oct/Nov spread as well as the Q1 contract. The front month contract finished the day on \$116.40.
