


## **London Iron Ore Market Report**



## 12 September 2023

Iron ore has dropped slightly on the day to finish at \$118.20. In the London morning session we saw interest in the Oct/Nov spread at \$2.15. Notably front month contract rose to a high of \$119.45 fuelled by positive economic data out of China. However the afternoon saw a reversal of the gain with the price contracting below \$118 post close. In the afternoon session we also saw most interest directed towards outright contracts, predominantly September and October.
