
## **London Iron Ore Market Report**



## 15 September 2023

Iron ore has once again had a hectic day, especially with the spreads. The front month contract dropped on the day to finish at \$120.45. The fall in the price was significant in the the afternoon session dropping from \$122.60 to a low of \$119.60. The day saw a lot of volatility in the spreads. In London morning we saw most interest in the Q4/Q1 spread at the \$5.1 level. In between sessions we then saw focus shift to outrights in large volumes. The afternoon session was then dominated by the Oct/Dec spread at around the \$4.60 level.
