
## **London Iron Ore Market Report**



Iron ore has dropped on the day to finish at \$121.80. The London morning saw interest in predominantly spreads, especially quarter spreads. The Q2/Q4 spread widened considerably, to a high of \$6, and was trading in a lot of size. Liquidity was also present further out the curve with cal 24/25 trading. London afternoon session saw a dampen in activity, probably as traders await the FOMC decision. The session opened with the front month contract soon falling almost a dollar.
