


## **London Iron Ore Market Report**



## 27 September 2023

This afternoon iron ore dropped off slightly to finish at \$115.75 by Ldn afternoon close. We saw the spreads continue to move with the Oct/Nov widening to \$2.50, whilst we saw Nov outright trading in large size. Likewise the Oct/Dec traded in a large size at \$4.55. We saw little activity further out the curve.
