



As expected Iron ore had a quiet day due to the holiday in China. The price has risen over a dollar on the day to finish at 120.40. In the morning we saw some Oct/Nov trading in large size. Spreads in the day continued to have the most interest, with liquidity being added further down the curve with Q3/Q4 trading at 2.85.
