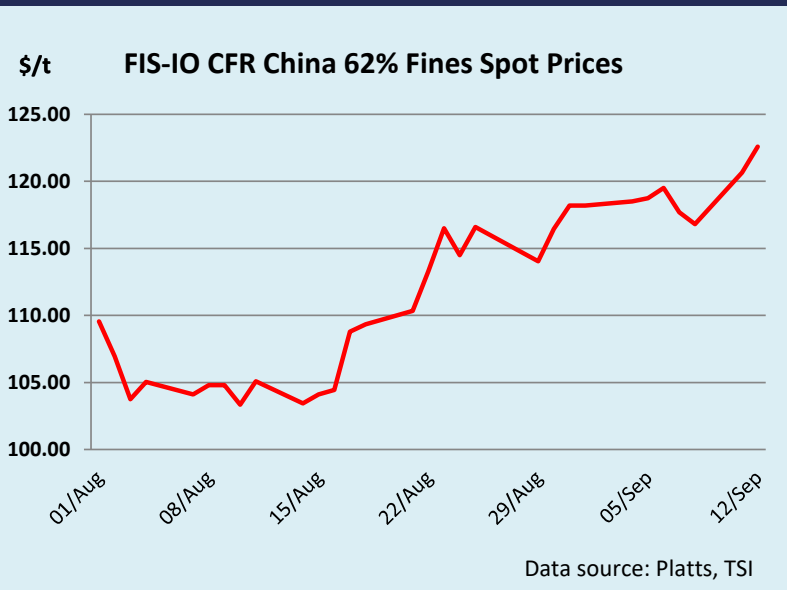

Iron ore futures continued its rally on Tuesday, Sept opened higher at \$120.25 and gradually edged up in the rest of the session to \$121, likewise Oct climbed towards \$119. Another day was focus on the spreads trading, Oct/Dec traded at \$3.6 in large clips throughout the session, decent interest also saw on Oct/Nov changing hands at \$2.15 and on the far back Cal25/26 traded at \$5.8 in 24kt.

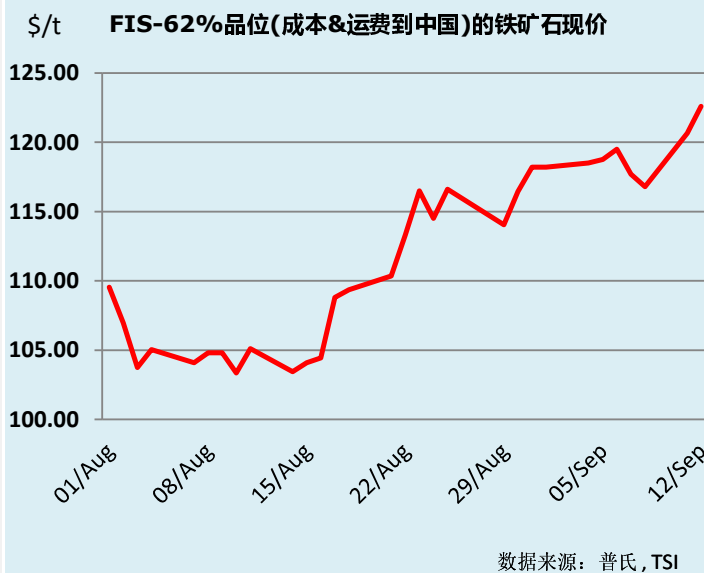
