

Market Commentary / Recent Trades

Iron ore continued its upward trend supported by increasing steel production and iron ore restocking activities before the Chinese week-long holidays at the end of this month. China Iron & Steel Association (CISA) reported steel production went up 5.5% or 113,200 tonnes/day to 2.16 million tonnes during the first ten days of Sept. in the futures market, trading activity has slowed down a bit compared with yesterday. Oct/Nov was traded several times at \$2.15, all in large sizes, some interests also showed on Oct/Jan. On the outrights, Oct initially dipped to the day's low of \$117.7 in the early London morning, before rebounded again to \$119.3.
