Market Commentary / Recent Trades

This morning has seen an uptick in the iron ore price. We rose to a high of \$117 post the London morning, buoyed by positive industrial profits. We have seen the Oct/Nov spread trading in large sizes, with the spreads widening to \$2.45. The Oct/Dec spread has also seen some considerable interest with some liquidity being provided further out the curve with Q1s and Q2 trading.
