


#### **Oil and Energy Market News**

US oil production continues to ramp up amid OPEC cuts, with their output up again in July to 12.99 million barrels per day, nearing the pre-pandemic record. Numbers are up even in the face of a steep downturn in drilling in the world's largest economy.

Brent crude futures are trading marginally higher on the day here, having settled last night at \$90.71/bbl. The bullish rally seems to have lost some momentum.

The VLSFO cracks approach UK market close only marginally weaker on the day, whilst the HSFO Rotterdam crack is flat on the day. However, with the HSFO EW collapsing again, the Sing 380cst crack is a dollar weaker at -\$15.30/bbl in the front month.

The HSFO EW came off \$5.50 from settlement to trade last at \$11.50/mt for Nov23.

Fuel spreads were choppy across the board today, all closing the day weaker in the prompt contracts.


