


#### **Oil and Energy Market News**

Dec23 Brent crude futures settled last night at \$84.07/bbl after another day of heavy losses as worries about fuel demand outweighed an OPEC+ decision to maintain oil output cuts.

Both the Brent and WTI oil benchmarks have shed about ten dollars per barrel in price in just under 10 days, having edged almost to \$100/bbl late last month.


