



Oil and Energy Market News

Front month Brent crude futures are trading much higher than Friday, where they settled at \$84.58/bbl as the market digests the devastating attacks on Israel over the weekend and the retaliatory actions taken by Israel in Gaza. Israel is a very small producer of oil in the grand scheme so the recent events will have little impact on supply – the market is purely reflecting an increased risk premium until there is clear deescalation.


