


#### **Oil and Energy Market News**

Crude oil traded extremely volatile today, particularly after the US open when news hit the market that the nation neared a deal to soften the sanctions on Venezuelan oil. Upon the announcement, front month Brent crude futures dropped sharply to touch the intraday low of \$89.50/bbl.

Despite crude slipping today, there is no disregarding that Israel's expected ground offensive against Hamas is keeping the commodity markets on edge.

VLSFO cracks are marginally stronger on the day, up about 15 cents in both the Sing and the Euro – at \$11.15/bbl and \$2.30/bbl, respectively.

Sing 380cst spreads strengthened today, with the front Nov23/Dec23 contract up over a dollar on the day at \$4.75/mt. The equivalent spread for the VLSFO softened by 50 cents.

Front Sing Hi5s are about 20 dollars stronger on the week on a much weaker HSFO crack.


