


Oil and Energy Market News

Brent crude futures are trading flat on the day here, holding on to yesterday afternoon's gains after headlines around Israel's ground invasion plans formalised. Dec23 Brent crude futures settled last night at \$90.13/bbl.

The current situation in the Middle East has added a "war premium" to crude prices but Bloomberg is reporting that physical prices are easing as refiners reduce gasoline production ahead of the northern hemisphere winter.

Fuel cracks are weaker across the board, down 25 cents in the front HSFO front Euro crack to trade last at -\$15.40/bbl. The VLSFO Crack traded last at \$10.75/bbl – 24 cents weaker on the day.


