
Panamax Commentary


Early trades today on the deferred contracts with cal24 printing \$13800 a couple of times in the Asia session. As European traders arrived at their desks the prompt contracts came under some heavy pressure with 18100 sold Nov (-500) and quickly \$18000. The selling was relentless with bids continually hit down to a low of \$17000 on Nov post index where good volume changed hands. Cape Q1 was sold down to \$8250 (-350). The afternoon session saw late buyers with Nov and dec paid much higher and quickly – \$17750 eventually getting paid on Nov and closing well bid. Have a great evening.

Capesize Commentary

It was a rather patchy day in terms of activity on Panamax paper with rates range bound and despite some good volume still changing hands we finished the day only marginally higher than where we started. The Nov v Dec spread opened up to \$1k trading up to \$1050 high. Q1 tested but didn't break \$9k resistance and further out cal24 traded down to \$10750 low before pushing back up to \$10850. With the Capes pushing at the close we closed supported just under the days highs.
