


## **London Iron Ore Market Report**



Iron ore DCE continues to be closed. The front month contract has dropped over a dollar on the day to finish at \$115.75. Prior to the London afternoon we saw selling interest in October in a lot of size. Oct/Nov also traded in size. The afternoon in London saw very little liquidity, but we did continue to see interest in the Oct/Nov spread at the \$2.5 level.
