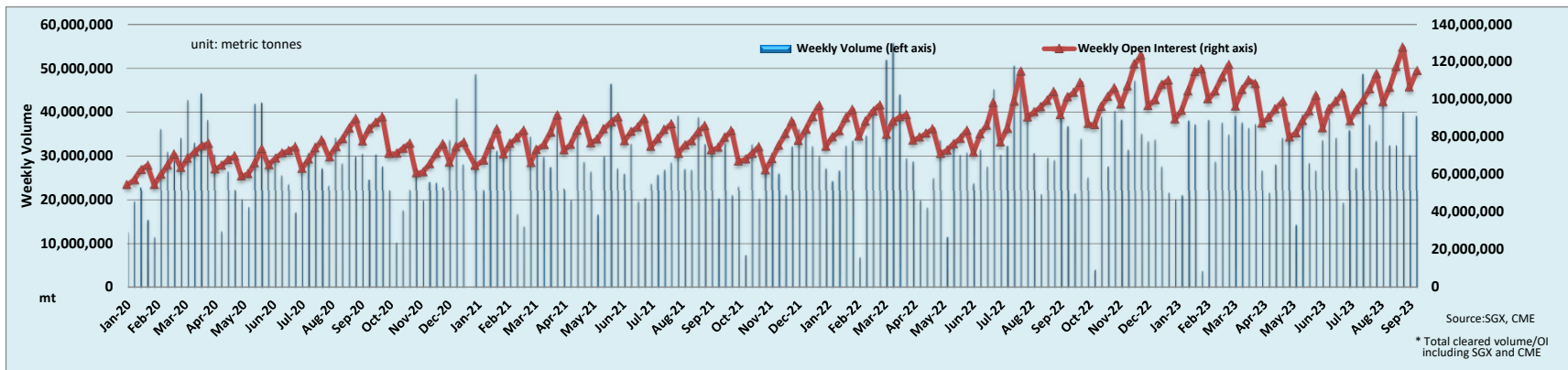
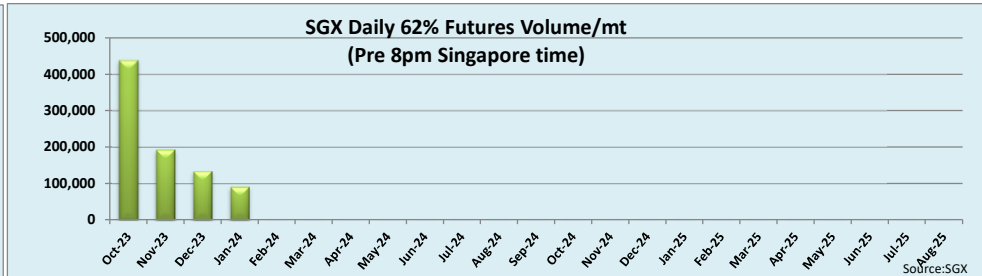
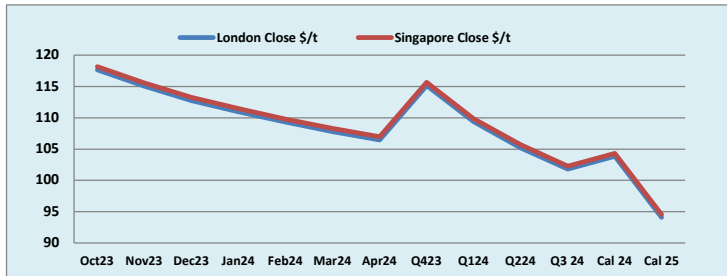

We have seen the Q4/Q1 spread widen to \$5.85, and the Oct/Jan spread trading at \$6.6 in large size. London afternoon saw some selling interest for the October contract.
