





The day saw Nov/XXX spreads attract considerable interest. London morning also saw Q3-24/Q3-25 trading at \$10.1 in size. Liquidity was further provided out the curve with Cal 25/26 trading \$7.25. Tomorrow sees a lot of PMI data coming out, providing an insight into the health of economies.
