


Iron ore has had a mixed day, rising to a high of \$117.50 to then close at \$116.80. The trading of the day was dominated by the Nov/Jan spread which was trading at \$4.55 in size in the T session, to later be trading \$4.45 in the T+1 session. The Nov/Dec spread was also trading in size at \$2.4. The T+1 session saw little activity on outright contracts, however Nov/Q1 traded in size at \$6.4. We also saw some Dec/Mar interest in the London afternoon.
