

Market Commentary / Recent Trades

After yesterday's sharp fall, iron ore futures traded in a narrow range on Tuesday. Overall, a busy session after more participants returned from holiday. Nov contract ticked up from sub \$110 to \$110.5 and then \$111.3 in thin volumes. Dec traded a touch higher at \$108.25 in 15kt during mid-session and Jan at \$105.4. More trading interests were seen on the spreads, with decent volumes changing hands on Oct/Nov from \$4.5 up to \$4.6, large clips of 102kt Nov/Jan was trading at \$4.45, further back Q1/Q3'24 traded numerous times at \$8.1.
