
#### Oil and Energy Market News


Brent crude futures climbed in the late afternoon after touching intraday lows of \$84.64/bbl in the front month. Headlines suggesting that risks in the Middle East are worsening amid some escalation in the Israel conflict. That being said, front month Brent remains below the high of 87.39\$/bbl from yesterday.

Gains are limited by global demand still being uncertain with concern for the economic recovery in China after disappointing PMI data this week as focus switches to the US payrolls data due on Friday.


