
#### Oil and Energy Market News


Brent crude futures extended their recovery this afternoon, with front month futures trading an intraday high of \$81.48/bbl. This has helped to counter some of yesterday's decline. That being said, front month futures are still net down about 7% on the last five days.

Saudi Energy Minister Prince Abdulaziz bin Salman has said that the recent fall in oil prices is due to speculators in the market and that oil demand is actually healthy.

HSFO Rotterdam crack found strength today, even with a rallying crude, printing last at -\$13.70/bbl in the front month -\$1.35 stronger on the day.


