


### **Oil and Energy Market News**

Crude markets have been extremely volatile today, trading a range of well over four dollars as OPEC+ decisions were announced. Brent crude futures have fallen drastically this afternoon, erasing any earlier gains that followed the OPEC+ meeting. The group is planning to cut output by 2mbpd during 1Q24 according to delegates and this saw the Feb24 Brent crude future hit an intraday high of \$84.61/bbl, before tumbling to a low of \$80.03/bbl. Strong USD and the resumption of loadings from Black Sea ports have offered downward pressure this afternoon.
