


Iron ore has risen very slightly since the end of last week with the front month Dec contract closing at \$123.40. The T session saw Dec/Feb trading in considerable size, whilst the beginning of the day also saw Dec/Q1 trading at \$4.05 in size. The T+1 session was relatively subdued with Jan spreads dominating most of the session, Jan/May \$7.05 and Nov/Jan at \$4.3. Eyes will be focused on trade data out of China tomorrow as a guide to the health of the economy and its intricacies.
