


London Iron Ore Market Report



Friday evening saw minimal action in iron ore closing at \$129.15. Soon after DCE open the front month dropped to its low of the day at \$127.85 before quickly rising again. Liquidity was thin with only notable trading of Q1/Q4 at \$13.5 and Dec/Feb at \$3.8.
