


London Iron Ore Market Report



In the London afternoon session iron ore hit a new high of the day at \$134.15, but came off to finish at \$133.80. Liquidity in the afternoon was low especially amongst outrights. However, despite this there was Dec/Q1 interest with it trading at \$3.3 in large size. Elsewhere we saw a continuation of Quarter spreads trading but in small size.
