During Singapore trading, iron ore has risen over two dollars, since close yesterday, to a high of \$122.75 . Dec/Jan has been very popular, trading at \$2.2 in considerable size. Quarters have continued to gain interest and we saw Dec/Q1 trading \$4.1. We haven't seen much liquidity further out the curve, but Cal 24/25 interest has been expressed.
