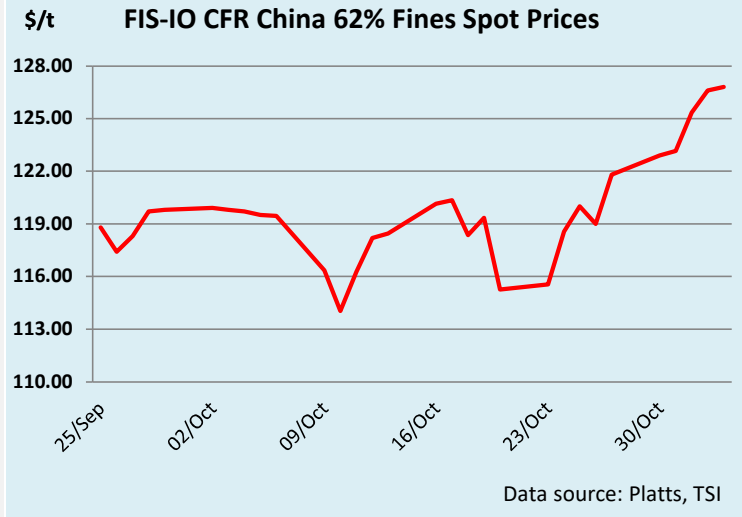

## Market Commentary / Recent Trades

Singapore trading today has seen iron ore be quite volatile. In the morning iron ore rose considerably on yesterday's close to a high on the day of \$123.75. This momentum was short lived, with the price dropping over two dollars to a low in the afternoon DCE session of \$121.65. Post close has seen a mild uptick in the price as liquidity drops off before the London afternoon session. Dec spreads have been trading the most, most notably Dec/Q1 at \$4.15 in size.

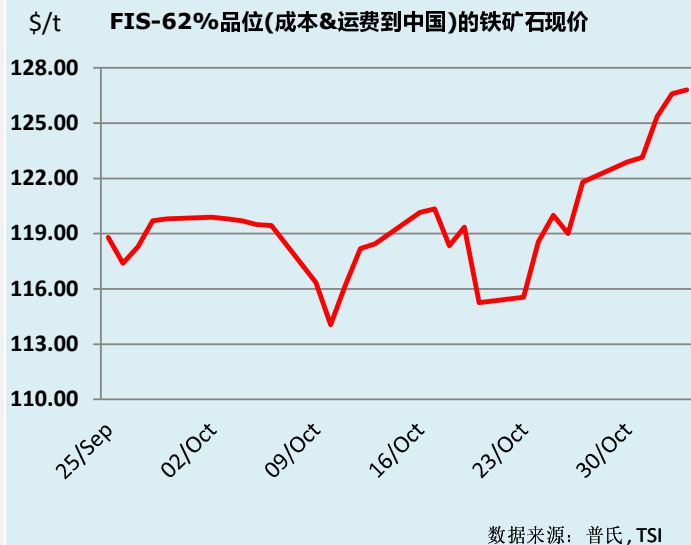

今日新加坡交易时段铁矿石价格波动较大。早盘铁矿石价格在昨日收盘的基础上大幅上涨，至123.75美元的高点。这种势头仅短暂持续，随即价格下跌超过2美元，在下午的大商所交易中跌至121.65美元的低点。由于伦敦午后交易时段前流动性下降，收盘后价格出现小幅上涨。12月价差交易最为活跃，尤其是12月/Q1交易于4.15美元。
