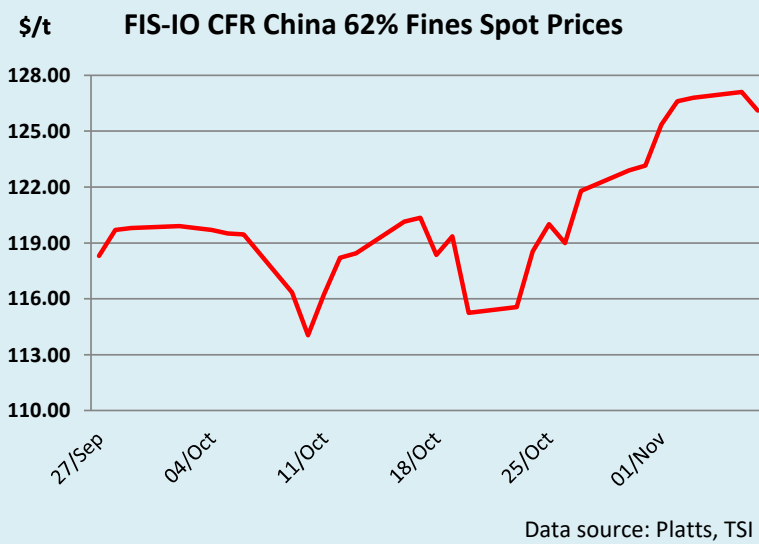

Market Commentary / Recent Trades

Iron ore slipped a touch following lower trading prices in both seaborne and portside markets along with timid volumes. Prompt futures edged lower over the Asian day session, Dec opened below \$123 and spent most of the session trading at around \$122.7, Jan and Feb steadied at \$121 and \$118.7, respectively. More activity was reported on the Dec spreads side with good sizes trading on Dec/Jan at \$4.05 throughout the session, and decent volume on Dec/Jan at \$2.2. Further on the curve, Q1/Q2 changed hands at \$5.2 in 30kt. Elsewhere, the International Monetary Fund lifted China 's GDP forecasts to 5.4% this year and 4.6% next year given its economic recovery data in Q3 and recent stimulus from the policymaker, although risks remain in the property sector.

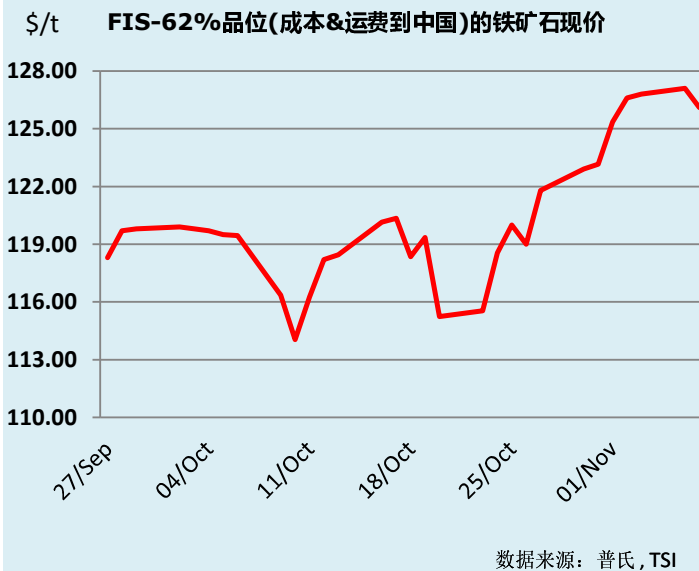

市场评论 / 近期交易

由于海运和港口市场的交易价格双双下跌，同时成交量放缓，铁矿石价格小幅下跌。即期合约在亚洲交易时段小幅走低，12月期货开盘低于123美元，多数时间在122.7美元附近，1月和2月分别稳定在121美元和118.7美元。据报道，12月价差方面交易更加活跃，12月/2月在4.05美元有可观交易量，12月/1月交易于2.2美元。Q1/Q2在5.2美元交易3万吨。其他方面，鉴于中国第三季度的经济复苏数据以及中国政府近期出台的刺激措施，国际货币基金组织(IMF)将中国今年和明年的GDP增长预期分别上调至5.4%和4.6%，尽管房地产行业仍存在风险。
