#### Market Commentary / Recent Trades

Iron ore in Singapore initially dropped due to poor new home sales in cities in China to a low on the day of \$126.70. However post the second DCE close, iron ore rose to a high of \$128.75 on the news that China was thinking about injecting 1 trillion yuan to help the housing market. Trading wise there has been a lot of trading on Q1/Q2 at \$5.15. The Dec/Jan and Dec/Feb spreads have also traded in considerable size as the spreads have narrowed throughout the day.
