Market Commentary / Recent Trades

Both seaborne and portside iron ore prices strengthened on Monday, accompanied by increased trading volume. During the Asian day session, iron ore futures saw a gain of over \$2, pushing prompt months back above the \$130 threshold. The active Dec contract opened at \$129, quickly escalating to the high \$130s and reaching \$131.15 in substantial volume. Notably, there was heightened interest in the spreads, with Nov/Dec trading from -0.70 to -0.60, Dec/Jan stabilizing at \$1.7 in over 100kt, and further back, Dec/Q1 seeing trades at \$3.5.
