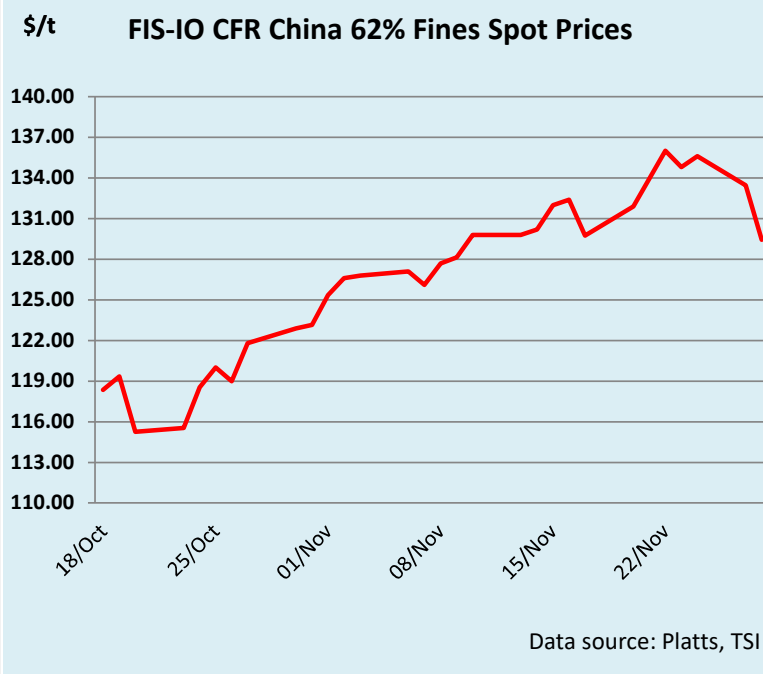

Market Commentary / Recent Trades

Today iron ore has considered its considerable decline in the wake of weeks of gains. In Singapore trading the front month contract dropped to a low of \$127.60. The NDRC pressure on the strong iron ore price has continued to weigh heavily on the market. Q1/Q2 spread has continued its traction at \$5.10 whilst we have seen Jan/Q1 trading at \$1.85 in size. Jan/Mar spreads have also had interest Mar/May trading at \$3.35.

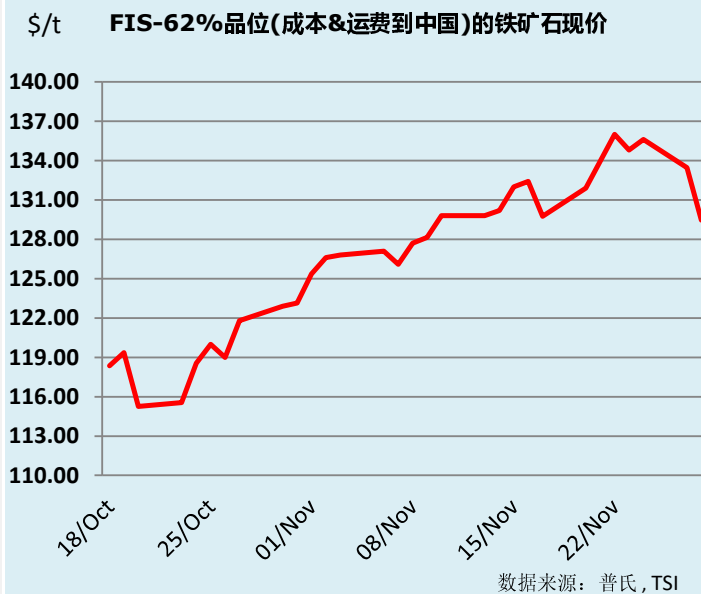
