


Brent crude futures are pushing higher still, this morning, surpassing the highs of yesterday amid amid fresh concern for shipping due to the Israel-Hamas conflict after another attack on a tanker in the Red Sea. The front Feb24 contract settled last night at \$76.03/bbl.

Near term crude time spreads are still in contango until the June 24 contract, suggesting ample supplies. The longer dated spreads are still in backwardation but much softer then seen in late November with Brent Jun24-Dec24 down at 0.99\$/bbl from around 2.3\$/bbl.


