
Oil and Energy Market News


Oil prices have held on to yesterday's gains after EIA data showed a larger than expected draw in US crude inventories, of 4.25 million barrels. Prices are also finding some support on the dovish Fed news and continued dollar weakness. Feb24 Brent crude futures settled last night at \$74.26/bbl.

The IEA monthly report is published later today and it will be interesting to compare its demand projections with the more optimistic OPEC ones released yesterday.


