


Oil and Energy Market News

Front month Brent crude futures are flat on the day here, having settled last night at \$79.70/bbl. Prices have risen for three days, supported by increasing threats from Houthi's on global shipping aiming to pass the Suez Canal, despite the planned US-led naval task force to secure the area.

Putting a ceiling on oil prices, though, has been the EIA data this week that showed an unexpected build in crude stocks, as well as US crude output hitting a new record high of 13.3 million bpd.


