Market Commentary / Recent Trades

Iron ore maintained its upward trend on Friday, even as DCE increased oversight on onshore iron ore products. December prices held steady between \$132.4 and \$132.7, while January saw an uptick to \$131.3, where the majority of volumes were exchanged. The primary focus in spreads was on Dec/Mar, with 150kt traded at \$4.80.
